**AN ORDINANCE FOR THE LEVY OF TAXES  
FOR THE PARK DISTRICT OF HIGHLAND PARK FOR  
2021**

**BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE PARK DISTRICT  
OF HIGHLAND PARK, COUNTY OF LAKE AND STATE OF ILLINOIS, AS FOLLOWS:**

**SECTION 1:** That the sum of Twelve Million, Three Hundred Eighty-One Thousand, Six Hundred Sixty-Seven Dollars (\$12,381,667) being the total amount required to be raised by taxation for the year 2021 by the Park District of Highland Park, Illinois for all corporate purposes of said Park District and for purposes of providing for the Corporate Fund, a Recreation Fund, and a Special Needs Recreation Fund be and the same is hereby levied upon all taxable property within said Park District of Highland Park subject to taxation for said year in the amounts and for the uses and purposes itemized below:

**SECTION 2.** That the total amount of Twelve Million, Three Hundred Eighty-One Thousand, Six Hundred Sixty-Seven Dollars (\$12,381,667) itemized as aforesaid, be, and the same is hereby levied on all property subject to taxation within the Park District of Highland Park according to the value of said property as the same is assessed and equalized for State and County purposes for the year 2021.

**SECTION 3.** That there is hereby certified to the County Clerk of Lake County, Illinois, the several sums aforesaid constituting Twelve Million, Three Hundred Eighty-One Thousand, Six Hundred Sixty-Seven Dollars (\$12,381,667) which said total amount the said Park District of Highland Park requires to be raised by taxation for the year 2021 of said Park District, and the Secretary of said District is hereby ordered and directed to file with the County Clerk of said County on or before the time required by law, a certified copy of this Ordinance, along with the certificate of the Park District's presiding officer pertaining to compliance with the Truth in Taxation Law.

**SECTION 4.** Pursuant to Section 4-4 of the Park District Code, 70 ILCS 1205/4-4, neither the Park District's Budget and Appropriation Ordinance for the fiscal year beginning on January 1, 2022 and ending on December 31, 2022, nor any other Budget and Appropriation Ordinance is intended to or required to be in support of or in relation to the Levy made by this Ordinance.


**SECTION 5.** This Ordinance shall take effect and be in full force and effect immediately on and after its passage and approval.


## CERTIFICATE OF PRESIDING OFFICER

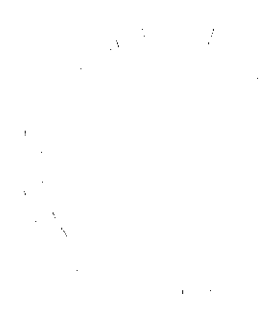
