#### <u>Summary</u>

At the Facility and Recreation Committee on November 4, 2022, Holabird and Root presented the results of the preliminary planning services looking at how to address the aging West Ridge Center. At this meeting, the Committee recommended consulting with a firm to conduct a financial and operational assessment to identify priority spaces. Since then, Staff has been working with BerryDunn to complete the assessment. Staff will review the next steps for the new community center at West Ridge Park as well as review progress of the BerryDunn assessment.
